## Notice for the use of Photographs and Videos for ACT publicity purposes

The purpose of this Notice is to provide information and notification to students and seek appropriate consent, if needed, regarding the use and publication of photos, videos, and audiovisual material that capture and depict moments during the academic life, extracurricular activities at ACT – American College of Thessaloniki and other relative events/ activities.

This Notice <u>does not apply</u> to photographs of students that are intended to be used for <u>identification purposes</u>, as part of the Institution's obligation to ensure the proper access to services, premises, and infrastructure, for safety and security purposes, and to prevent fraudulent activity.

This Notice <u>does not apply</u> to group photos or photographs where the individuals <u>cannot</u> <u>be identified or appear incidentally</u> in the background of publicity shots, and they are not the focus of the image, such as in crowd scenes.

The Trustees of Anatolia College which operate ACT - the American College of Thessaloniki – ACT is committed to respecting your privacy and personal data according to the General Data Protection Regulation/ GDPR (EU) 2016/679, the Greek law 4624/2019 for the harmonization of Greek legislation with GDPR, and all relevant Greek legislation for the protection of personal data, electronic communication, and intellectual property.

Photos and videos and other audiovisual material are taken by the official photographer of Anatolia College/ ACT faculty, staff, and in some cases students. They are stored and secured in Anatolia College/ACT databases and equipment, for educational and archival purposes. They are published and/or uploaded in Anatolia College and ACT websites, printed and online magazines, newsletters, posts on social media, and in printed and online news media outlets.

Additionally, they may appear in promotional/material of the institution.

In order to use an image for the above mentioned purposes and when a person can be clearly identified in the photo/video/audio-visual material, we need to have your freely given, specific, informed and unambiguous **consent** as required from the GDPR, the relevant applicable laws, and the <u>Anatolia College Privacy Notice</u>.

You can withdraw consent for this at any time by submitting your request to <a href="mailto:privacy@anatolia.edu.gr">privacy@anatolia.edu.gr</a>. This will not apply to material already published online or printed since the institution cannot control already published material or recall them. The institution will then take all reasonable efforts to enact this request as quickly as possible
